OUR ORGANIZATION

Created in 1990 by REALTOR® members, the Santa Clara County REALTORS® Foundation has contributed many thousands of dollars to a wide variety of local charitable organizations. The Santa Clara County REALTORS® Foundation is a non-profit organization consisting of over 5,000 REALTOR® and Affiliate members. The Foundation is a 501(c) 3 non-profit corporation.

OUR VISION

To create a legacy of giving back to the community by engaging real estate professionals in a context larger than themselves so that our influence will be seen and felt by the families we serve and the communities we support. In doing so, the entire community in which we live and serve is directly enriched by our efforts.



ELIGIBILITY

All grant requests are eligible for consideration and they will be evaluated based on the criteria below:

EVALUATION

Applicants will be evaluated on the following:

- The community need for the expenditure, and the number of people who will be served.
- The impact on the recipient organization.
- The location of community served. Although requests for state, national and international projects may be considered, preference will be given to projects with a more local base.
- The financial soundness and efficiency of the organization.
- Accuracy and completeness of the application.
- The structure of volunteer organization and level of volunteer support.

There will be two request periods:

- Spring grant requests are due by December 31st of the previous year
- Grants for Spring will be awarded before March 31st
- Fall grant requests are due by June 30th of the current year
- Grants for Fall will be awarded by September 30th

SCCR Foundation Grant Guidelines

- 1. A Foundation Grant Request form must be completed and sent with the following:
 - a. A cover letter signed by the Executive Director or other responsible party
 - b. The purpose of the grant and how the funds will be used
 - c. A list of the applicant organization's Board of Directors and Executive Staff
 - d. Current P&L and Balance Sheet with year-to-date financial statement
 - e. Annual budget
 - f. A copy of the IRS tax-exempt determination letters
 - g. A copy of two prior year's tax returns with the Federal 990 tax returns
 - h. All awards must comply with SCCR Foundation By-Laws and awarded per 501(c)3 guidelines.
 - i. Grants will **NOT** be awarded for capital improvements, employees' salaries, event funding, membership fees, or to any individual.
 - j. If a grant is awarded, applicant must provide an annual accountability report stating how funds were used and who benefitted from the program

Applicants without the above documentation may be considered at the Foundation's discretion

- 2. Applicants may make an in-person presentation to the Foundation committee.
- 3. Foundation committee members may do an on-site visitation to applicants' organization.
- 4. As a general rule, grants will be capped at \$5,000.00. Grant requests that exceed the \$5,000.00 maximum may be considered for additional funding in the next grant time period.
- 5. All grant requests that are not awarded, will receive a letter declining their request.
